Community Awareness

Please remember:

Lorton Landfill and EnviroSolutions (ESI) Green Energy Park

The Lorton Landfill is operated by EnviroSolutions (ESI). ESI's current contract expires in 2018. Currently, ESI is in discussion with Fairfax County regarding an extension of the current contract. There is a great deal of discussion from interested parties in the South County area. Below is information from South Run Coalition on pros and cons to the ESI Special Exemption Amendment Application.

What is gained as identified by South Run Coalition if the ESI plan is approved:

- \$27.7+ million in cash benefits for local community needs.
- \$13+ million investment in renewable energy technology, parks and ball fields.
- Renewable energy park unique to the United States
- Millions in revenue shared with Fairfax County taxpayers from wind and solar electricity sales.
- Education center for renewable energy at Lorton Workhouse Arts Center.
- Rebrands Lorton/South County Area from trash-industry corridor to new technologies center of excellence.
- Parkland for public use with amenities on neighboring ESI property.
- Potomac/Occoquan River overlook/observation post

- No mixed-waste trucktransfer/recycling facility in perpetuity.
- No added truck traffic on local roads.
- No increase in landfill's height.
- No tax payer funds required.

What is lost as identified by South Run Coalition if the ESI plan is not approved:

- \$89.5 million lost in expenditures, taxes and fees after landfill closure in 2018.
- \$15.1 million lost in in-kind services/resources (dredge soils, Habitat for Humanity, etc.).
- More waste facilities in Southern Fairfax County to replace the closed landfill.
- Landfill does not go away; it merely closes and recycling activity moves across the road.

- Significant truck traffic increase on our roads to/from new waste facilities.
- No rebranding our image. Lorton/South County Area remains as Fairfax County's industrial/trash corridor.
- Increased greenhouse gases and diesel fuel consumption due to more trucks.
- \$27.7 million lost in cash for local community needs.
